Minimum Requirements for the Apprentice Registration:

- Must provide proof that the applicant is authorized to work lawfully in the United States
- Must be at least 16 years of age
- Fingerprints are required for all Apprentice Registrants. This is a one-time, state-mandated obligation that cannot be transferred between agencies. See the final page of this application for details.
- Must submit non-refundable Apprentice Registration application fee (\$15)

If the applicant has a plumber's apprentice registration that is current or has been expired for less than two <u>years</u>: DO NOT REAPPLY. Instead, either renew the applicant's license online (see top of this page) or call the TSBPE Licensing Department at 512-936-5248 to request a renewal form.

<u>Processing Time</u>: Allow up to 45 business days for the processing and return of your pocket card when sending applications via the US postal service. As stated at the top of this page, Apprentice Registration Applications submitted online are processed considerably faster than physical applications sent via US Mail.

<u>High School Accelerated Training (HAT) Program:</u> Students enrolled in a qualified High School Plumbing Training program are registered as a standard Plumber's Apprentice but are not subject to the initial application or renewal fees as long as they remain enrolled in training. Please see the "Printable Forms" page on tsbpe.texas.gov to download the **Apprentice Registration Application for HAT Participants**.

<u>Renewal of Registration</u>: Plumber's Apprentice Registrations are assigned a random expiration date. The expiration date will be printed on the pocket card the applicant will receive after their registration application is approved. Apprentice registrations must be renewed each year on or before the expiration date. A renewal notice will be sent via email approximately 65 days before the registration's expiration date. It is the Apprentice's responsibility to make sure his or her current address is on file with the Board. All personal information can be updated quickly using the Online Licensing System (see above).

<u>The Applicant's Identity Will be Verified</u>: Current (not expired) US or state government-issued photographic identification, such as a driver license, passport, or state-issued identification, must be submitted with this application.

<u>Credit for Work Experience</u>: When applying for a plumbing license or certain endorsements, applicants must submit proof of work experience in the plumbing trade. <u>APPLICANTS WILL ONLY RECEIVE CREDIT FOR HOURS WORKED IF THE WORK WAS COMPLETED WHILE THE APPLICANT HELD A CURRENT PLUMBER'S APPRENTICE REGISTRATION.</u>
