**IMPOSITION OF
ADMINISTRATIVE PENALTIES**

BOARD ORDER

On the **10th day of October, 2016**, the Texas State Board of Plumbing Examiners, (Board), considered the matter of the following Administrative Penalties recommended by the Enforcement Committee, in accordance with the Board's Administrative Penalty Schedule, and agreed to be paid by the Respondents listed herein. In accordance with the Texas Administrative Procedure Act, the Plumbing License Law and the Board's rules and policies, the Enforcement Committee provided each Respondent with a Notice of Alleged Violation, stating the nature of the allegations of violations involved and afforded each Respondent of his/her entitlement to a formal hearing with representation, if desired. Each Respondent replied in writing to the Notice of Alleged Violation expressing his/her desire to waive a formal adjudicatory hearing and to comply with the Board's Administrative Penalty Schedule by agreeing to pay the indicated Administrative Penalty settlement amount. If the Respondent failed to abide by the agreement to pay the Administrative Penalty, the matter has been referred to the State Office of Administrative Hearings, (SOAH), and is so indicated on this Order.

NOW, THEREFORE, it is the ORDER of the Board that the following Administrative Penalties are imposed on the Respondents listed herein and are due and payable to the Texas State Board of Plumbing Examiners no later than the date herein indicated:
