

DRAIN CLEANER RESTRICTED REGISTRATION APPLICATION

REMINDER: This application (and many others) can be completed entirely online via the Online Licensing System. *Applications submitted online are processed and approved considerably faster than those sent via US Mail.* To login to your online account, go to: <https://vo.licensing.hpc.texas.gov>

Minimum requirements for Drain Cleaner Restricted Registration:

- Must have a **current** Plumber's Apprentice registration
- Must submit the Drain Cleaner Restricted Verification of Training Affidavit
- Must submit Drain Cleaner Restricted Registration application and fee (\$18)
- Must submit fingerprint data through IdentoGo (if you have not already done so, see final page of this application)

Renewal Details: The applicant's Drain Cleaner Restricted registration number is the same as the Apprentice Registration number. Applicant will receive a new pocket card containing a card that includes both the Plumber's Apprentice Registration and the Drain Cleaner Restricted Registration. The Drain Cleaner Restricted Registration will remain renewed if the corresponding Apprentice Registration is current.

Continuing Education: Effective January 1, 2010, applicants must complete at least 6 hours of Board approved Continuing Professional Education (CPE) in order to renew a Drain Cleaner Restricted Registration. A list of Board approved CPE providers is listed on the Board's website at tsbpe.texas.gov.

Scope of Work: In addition to the work performed by a Registered Plumber's Apprentice, a Drain Cleaner-Restricted Registrant may clear obstructions in sewer and drain lines only through any existing code-approved opening, only under the supervision of Responsible Master Plumbers and only under contracts or agreements to perform plumbing work secured by Responsible Master Plumbers. A Drain Cleaner-Restricted Registrant may not cut into sewer or waste piping, install cleanouts, and remove p-traps or plumbing fixtures, unless the Registrant is under the direct, on-the-job supervision of a licensed plumber. While performing only the work permitted under the Drain Cleaner-Restricted Registration, the Drain Cleaner-Restricted Registrant is not required to be under the direct, on-the-job supervision of a licensed plumber.

Board-Approved Training Prior to Tradesman or Journeyman Exam: Before an applicant may take an examination for a Tradesman Plumber-Limited license or Journeyman Plumber license, the applicant must complete classroom training provided by a board-approved instructor in a board-approved training program as required by Board Rule Section 363.12 for at least:

- (1) 24 hours, if the applicant is applying to take a Tradesman Plumber-Limited License examination; or
- (2) 48 hours, if the applicant is applying to take a Journeyman Plumber examination.

A list of providers of the 24- and 48-hour classroom training is posted on the TSBPE website.

Make Sure Applicant's Apprentice Registration is Current: The applicant's Plumber's Apprentice Registration must be current in order to apply for registration as a Drain Cleaner Restricted. In accordance with the requirements of Sections 1301.002 and 1301.354, of the Plumbing License Law, a person may receive credit for on-the-job work hours required to qualify for a Tradesman Plumber-Limited or Journeyman Plumber examination, only while the person holds a valid (current and not expired) Plumber's Apprentice registration, or a valid Tradesman Plumber-Limited license.

FINGERPRINTING INSTRUCTIONS FOR PLUMBERS & INSPECTORS

TSBPE IdentoGO Service Code: **11J66Z**

New and renewal license/registration applicants are required to obtain a fingerprint background check. Applicant's fingerprints will be submitted electronically to the Department of Public Safety (DPS) and Federal Bureau of Investigation (FBI) through IdentoGO. The fee is \$39.05 and is collected by IdentoGO. This fee is *in addition to* the applicant's initial license or renewal fees. Cash and personal checks are not accepted.

To register online:

1. Go to the TSBPE registration page on the IdentoGO website:

2. Click "Schedule or Manage Appointment" and complete the pages that follow.
3. When asked for an Authorization code, mark "No."
4. Do not request a hard card, as it will not be accepted by the TSBPE.
5. Make sure you bring proof of identification with you to the appointment.

To register by phone:

1. Call 1-888-467-2080. Use service code **11J66Z**. You **MUST** use this code. If you use the wrong code you will not be refunded for sending your information to another agency.
2. When asked for an Authorization code, answer "No."
3. Do not request a hard card, as it will not be accepted by the TSBPE.
4. Make sure you bring proof of identification with you to the appointment.

Once completed, the background check will then be sent electronically to the TSBPE, but please keep the receipt for record keeping purposes. **Fingerprint background checks for any other license or agency are not accepted as fingerprint data is not shared between State Agencies.** This service is NOT available at the TSBPE.
