

**Multipurpose Residential Fire Protection Sprinkler Specialist Examination Application**

**Minimum requirements for the Multipurpose Residential Fire Protection Sprinkler Specialist (MRFPS) Endorsement:**

- Must be currently licensed as a Master Plumber, Journeyman Plumber or Plumbing Inspector in the State of Texas.
- Must have completed a 24-hour Multipurpose Residential Fire Protection Sprinkler Specialist Endorsement Training program or hold a current RME-General or RME-Dwelling License issued by the State Fire Marshal
- Must submit MRFPS Endorsement application and fee (Master Plumber - \$80, Journeyman Plumber - \$27, Plumbing Inspector - \$40)

**Renewal Details:** The MRFPS Endorsement shares its license number with the plumber or inspector license it's attached to (see #5 on the next page). The applicant will receive a new pocket card containing a new plumber or investigator license card that includes the Multipurpose Residential Fire Protection Sprinkler Specialist Endorsement built-in to the same card. The Multipurpose Residential Fire Protection Sprinkler Specialist Endorsement will remain renewed as long as the plumber or inspector license is current.

**Scope of Work:** The Multipurpose Residential Fire Protection Sprinkler Specialist Endorsement allows for the installation, testing, and inspection of multipurpose residential fire protection sprinkler systems in one and two-family dwellings. The endorsement holder is responsible for ensuring that the system is installed by a licensed Journeyman or Master Plumber with the endorsement, and that the system has been designed by a licensed Master Plumber with the endorsement. The endorsement holder is also responsible for providing documentation, plans or drawings of the system, and instructions for operation, maintenance, and care of the system to the owner

**This Exam is NOT Computer-Based:** The MRFPS exam is a written exam administered in either the TSBPE's Austin or Waco locations.

**Make Sure the Applicant's Plumbing or Inspection License is Current:** The applicant's Master Plumber, Journeyman Plumber or Plumbing Inspector license must be current to qualify for the Multipurpose Residential Fire Protection Sprinkler Specialist Endorsement.

**The Applicant's Identity Will be Verified:** Current (not expired) US or state government-issued photographic identification, such as a driver license, passport, or state-issued identification, must be submitted with this application.
